SERVICES INCLUDE:

- Substance use evaluation
- Care Plan to address needs to include substance use, child welfare involvement, high risk pregnancy, housing and financial stability, parent and child health and wellness, criminal justice involvement
- Team staffing with Board Certified Addictionologist to determine ASAM recommendations to address substance use
- Coordination of all services to include substance use, mental health, medical, and any other identified service needs
- Group and individual support with a Certified Recovery Peer Specialist
- Circle of Security Parenting
- Ages & Stages developmental screenings for babies
- Pre and postpartum depression inventory
- Assist parents with ensuring they have all they need for baby

The Women and Family Intervention Services program includes three Recovery-Oriented System of Care (ROSC) components:

1. Family Intervention Services (FIS), which provides the tools for parents to develop substance-free lifestyles and strong family relationships. (Circuit 1)
2. Women's Intervention Services and Education (WISE), which assists pregnant and parenting women to ensure healthy moms, pregnancies, and children. (Circuit 1)
3. Substance Exposed Newborn/Neonatal Abstinence Syndrome (SEN-NAS), which supports families experiencing, or at risk for, SEN-NAS. (Circuits 1, 2, & 14)
